**OBJECTS OF THE TRUST:**

- i. The main object of the Trust is to help the poor and needy people.
- ii. To promote moral, social, educational, cultural, economic and physical interest of the public at large in general.
- iii. To grant of medical relief and help to poor and deserving patients by providing money's to them for medicine's, medical treatment, operation treatment, blood transfusion etc.,
- iv. The spread or promotion of Education and / or learning in all its branches including but not limited to public health in such manner as the trustees may think fit including,
- v. Establishment maintenance and support of studentships and scholarships for poor, needy and deserving students and scholar of the schools, college universities and other education or technical institutions.
- vi. Paying to needy students, school fees, college fees, books Instrument tools etc.,
- vii. Awarding scholarships giving loans to needy students on easy terms regarding repayment with or without interest or remitting the said loans in full or in part.
- viii. Paying whole or part of educational costs of deserving students.
- ix. Opening running and helping schools colleges, boarding houses, hostels and other educational institutions and imparting training and providing facilities for research and development.
- x. To render financial assistance to any charitable institutions, and in particular any hospitals, educational institutions and libraries.
- xi. To award scholarship or stipends to students to enable them to prosecute their studies and to award prizes to students for proficiency in any subject or language.
- xii. To give financial or corporeal aid or other help to poor people.
- xiii. To establish or take over to maintain and manage creches, homes for the old and disabled peoples.
- xiv. To promote rural play games to improve their personal skills.

- xv. To organizing medical camps, such as blood donations camp, eye checkup camp etc.,
- xvi. Self confidence motivation programme for students and Unemployment youth.
- xvii. To do all such other lawful things incidental or conducive to the attainment of the objects.

**Beneficiary Clause:**

- 1. The aforesaid objects of the Trust shall be for the benefit of the public namely, all persons irrespective of religion, race, caste, community or creed.
- 2. No activities of the Trust shall be carried on outside India and the activities shall not be carried on with the intention of earning any profit.

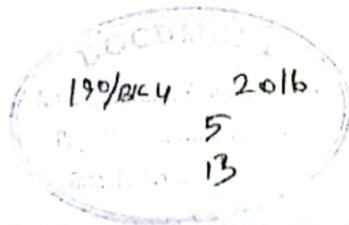
**DONATIONS AND CONTRIBUTIONS:**

- 3. The trustees shall have power and discretion to accept upon such terms as they shall think fit any donations, grants, subscriptions, aid and contributions from the Chairman and from any Government, Local authority, Corporation, firm or from any charitable trust or other institutions or from any person whether they may be in cash or in other movable or immovable property for the purposes of the trust PROVIDED ALWAYS that the terms upon which they shall be accepted, shall not in any way be inconsistent with or repugnant to the provisions contained in these presents. The trustees shall apply such donations, grants, aid subscriptions and contributions for all or any of the objects of the Trust keeping in view as far as possible the intentions of the grantors, and no portion of the income and funds shall be utilized for payment to the Trustees by way of profit interest dividend etc.,

**INVESTMENTS:**

- 4. All moneys which shall not immediately be required for current expenses shall be invested by the trustees in investments and securities authorized by Law for the investment of trust funds and in particular according to the provisions of section 13 (1) (d) read with Section 11 (5) of the Income Tax Act, 1961 or other relevant provisions of Law for the time being in force, or in Shares & Securities fixed deposits or savings bank account in any scheduled or nationalized bank or banks as defined in the Reserve Bank Act or in immovable property or in such other investments as may be decided upon by the trustees. The investments shall be in the name of the Trust only.

**NUMBER OF TRUSTEES:**

5. The number of Trustees shall be not less than Three and not more than Nine. The Trustees named in these presents shall be the first trustees and they shall be the permanent Trustees and each of them shall be entitled to hold office during his/her life time unless he/she in the meantime resigns or becomes disqualified to act as Trustees.

**MANAGING TRUSTEE**

6. **MRS.S.ALLAHUDEEN** shall be the Chairman and Managing Trustee and he shall hold office of Managing Trustee during his life time or until he resigns from the office of the Managing Trustee by notice in writing to the other Trustee/s. After he ceases to be Managing Trustee, any other person appointed by the Board of trustees shall be the Managing Trustee.

**CHAIRMAN OF THE TRUST**

7. The **CHAIRMAN** of the Trust shall perform and carryout and exercise all powers, duties and functions as the board may assign to him from time to time and exercise all such powers, privileges and discretion's and do all such acts, matters and things as may be necessary or convenient for administering the general policies and promoting the objectives of the trust.

The **CHAIRMAN** shall :

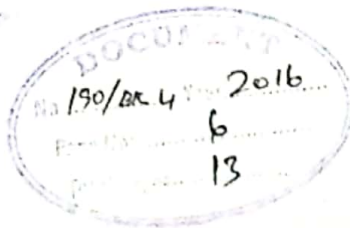
- 1) Carry out resolutions of the board of trustees
- 2) Sign papers, receipts and documents and documents relating to the trust.
- 3) Pay money due to the trust and demand and obtain receipts therefore.
- 4) Appoint doctors for free medical camps to fix their remuneration etc.

**TRUSTEES:**

8. a) The Board of trustees shall have the power to appoint additional Trustee/Trustees provided the total number of trustees for the time being shall not exceed nine. The trustee/trustees appointed under this clause shall hold office for such period from the date of appointment as may be specified by the Board of Trustees.

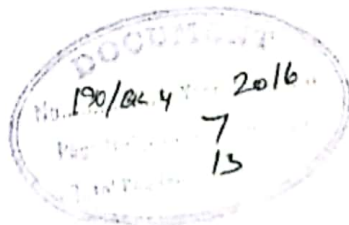
b) Vacancy among the Trustees may be filled up by the permanent trustees/joint managing trustees but if consequent upon the vacancy the number of trustees becomes less than three it would incumbent upon the trustee to fill up such vacancy.

c) The CHAIRMAN of the trust may remove any trustee appointed under this clause and shall give him/her notice in writing of such removed and on such removed he/she shall cease to be Trustee.

9. On any trustee ceasing to be a Trustee the trust property shall cease to vest him/her and on the coming of any new trustee the trust property shall vest in the new trust also along with the other continuing trustees.
10. The Trustees shall have all powers necessary or incidental for effectually carrying out the objects of the Trust.

**PROCEEDINGS OF THE TRUSTEES:**

11. The Trustees shall hold such meetings at such place and time as may be decided by the Managing Trustee and as may from time to time be necessary for considering any matter connected with the Trust or its affairs or to transact any business of the Trust.
12. The Trustees may make rules for regulating their meetings not being inconsistent with any provisions contained in these presents and they may make rules for passing any resolutions by circulation among the Trustees and the Trustees may repeal or alter any rules made pursuant to this clause.
13. A meeting of the Trustees may be called by a Trustee on not less than seven days notice in writing specifying the date, place and hour of such meeting and the nature of the business to be transacted at the meeting and such notice to, or the non-receipt of notice by any Trustee shall not invalidate the proceedings of any such meetings. With the consent of all the Trustees, a meeting may be convened by such shorter notice in such manner as the Trustees may think fit.
14. In all important matters and in particular in the matter of in-vesting or exercising the borrowing powers, the decision of the Trustees at a meeting or by circular resolution, shall be necessary.

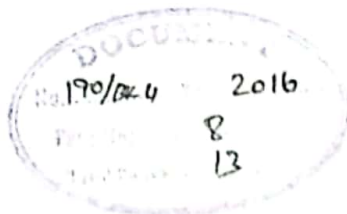

15. The Managing Trustee shall preside as chairman of every meeting of the Trustees, but if at any meeting he/she is not present, the Trustees shall choose someone of Trustees present to be the chairman of that meeting. In case there are joint Managing Trustees, the eldest shall be the chairman of the meeting.
16. At any meeting in which there is no unanimity of opinion among all the Trustees, the decisions of the majority shall prevail. In case the Trustees are equally divided, the chairman, shall have a casting vote.
17. A Minutes Book shall be maintained in which shall be recorded the proceedings of every meeting of the Trustees and shall be signed by the chairman of that meeting.
18. The continuing Trustee or Trustees may act notwithstanding any vacancy in their body.
19. All acts done by the Trustees or any of them or by any person acting at the instruction of any Trustee, shall notwithstanding that it be afterwards discovered that there was defect in the appointment of any Trustees or that any Trustee was disqualified, be as valid as if every such person had been duly appointed and was qualified to be a Trustee.
20. Any Trustee may at any time, with the consent of all his co-trustees, delegate all or any of his duties or powers to any other person or persons whether a co-trustee or not.
21. The Trustees may appoint any Trustees or other person to attend to or carry out any special function connected with the management of affairs of the Trust.
22. The Trustees shall be entitled to reimbursement of all expenses including all traveling and out-of-pocket expenses incurred by them for the purpose of the Trust or attending the meetings of the Trustees.

**CUSTODY OF DOCUMENTS:**

23. The Trustees for the time being shall have the custody of all deeds and documents of title relating to the Trust properties and investments and the books of account and other records relating to the Trust and shall be responsible for the same.

**BANKING ACCOUNT:**

24. All income, subscriptions and pecuniary donations for the general purposes of the Trust and the income of investments and all other moneys from time to time forming part of the general revenue of the Trust shall, on the same being received, be paid into a banking account or banking accounts with any scheduled bank which the Trustees may determine unless immediately needed for the purposes of the Trust. The banking account or banking accounts may be operated by the one of the trustee **Mrs.A.Sakeena** of the Trust, the funds shall be invested as per the provision section 11, 12 of income tax act 1961 and its late amendments.

**ACCOUNTS AND AUDIT:**

25. The Trustees shall keep proper books of account of all income and expenditure of the Trust and of assets and liabilities of the Trust. The accounts of each year shall be closed as on the 31<sup>st</sup> of March and shall be audited by a qualified Chartered Accountant.

**Amendment Clause**

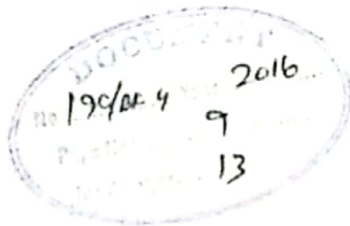

**Revocable Clause**

27. This Trust is irrevocable.
28. Not more than 5% of the Income of the trust would be applied for any religious purposes or given to religious Institution.

**Utilization clause**

29. Utilization clause as per Trust Act norms followed. The income of the trust utilized towards the object of the trust. No funds will not be utilized for payment to the author and trustees of the trust.
